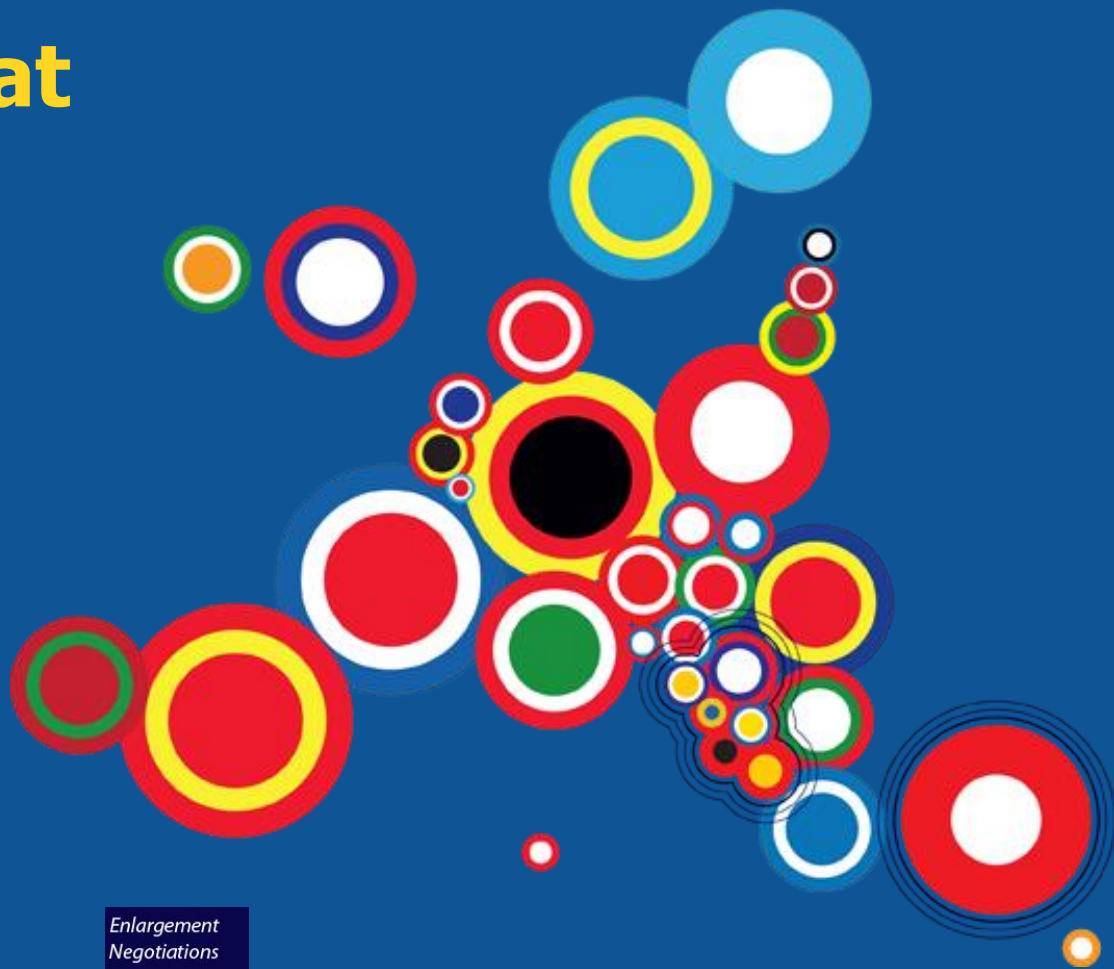

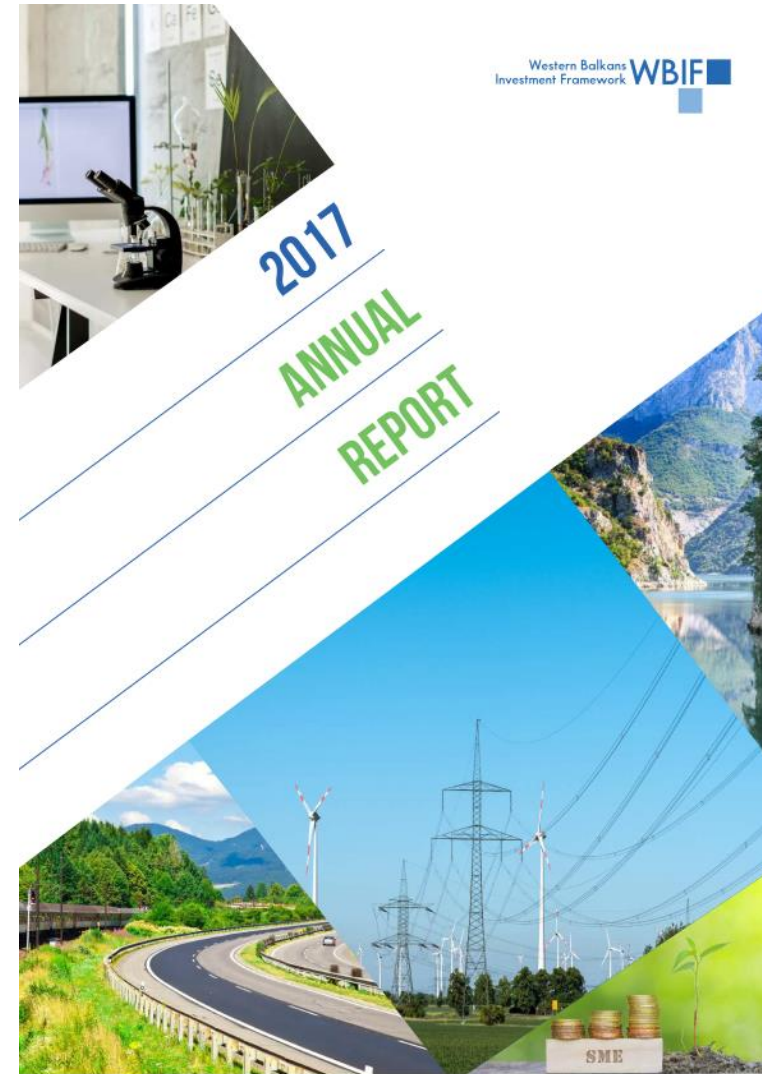

# Rules of Procedure, Vademecum

- *Certain events triggered need for updating RoP and the Vademecum;*
  - DII new WBIF sector;
  - KfW new partner IFI;
  - Extension 6 to 12 months PFG co-chair rotation;
  - Technical updates (Vademecum);
- *RoP were updated with WBIF\_WP17 ► MIS;*
- *Vademecum updated ► notified to WBIF Stakeholders*
- *Sanitized version for website ► circulate following SC;*

# Update NIC report

- *Stakeholder consultation done ► Reports final;*
- *Summary report to be disseminated (confidentiality concerns);*
- *Main findings:*
  - NIC framework transposed and operational;
  - Additional support needed in prioritisation and integration of SPP into mid-term financial planning;
  - Capacity building needed in NICs and Line Ministries;
- *Action plan implementation will start soon.*

# Update YESS

- *Stakeholder consultation finished, report final;*
  - One beneficiary – no data;
- *Main Findings:*
  - Significant potential for YE sector;
  - Fiscal space and non-revenue nature are barriers;
  - Mismatch between education system and market demands;
  - Lack of planning capacities;
- *Dissemination of YESS in autumn ahead of PFG.*



## Other updates

- *Funding needs / gap analysis (in progress)*
  - Methodology:
    - Review of WBIF pipeline (only);
    - Analysis split into sectors and beneficiaries;
    - Stakeholder consultation (IPFs – ongoing, IFIs next);
  - Draft report & results for PFG in autumn;
- *Ex-ante market assessment for proposed guarantee mechanism (in progress)*
  - Ongoing stakeholder consultations (currently IFIs);
  - Feed back from NIPACs needed (questionnaire);
  - Expect presentation of first findings before or at PFG.
